Deposits and Payments:

A deposit of \$350.00 per person will secure your cabin.

A second deposit of \$500.00 per person is due on August 21st, 2009.

Balance is due October 30th, 2009.

Cancellation policy:

Through August 21 st , 2009	\$350.00 deposit per person
August 22 nd - October 30 th	\$500.00 per person
October 31 st - December 18 th	50%
On or after December 18 th	100%

These penalties are in addition to any non-refundable airline tickets you may have purchased.

Insurance: Trip cancellation insurance is available from \$98 per person and is strongly recommended. Full details will be mailed to you upon request.

Flights: If you need assistance with flights please indicate accordingly on your Registration Form. Please schedule to arrive **no later than 1PM** on the day of sailing and depart **no earlier than 12:00 NOON** on day of disembarkation.

Pre-night accommodations: Our pre-night stay is a great way to get the craic started early! Come meet fellow travelers and ease into your vacation. Limited rooms are available at the Embassy Suites Ft Lauderdale on January 23rd. \$190 per person sharing includes: room, tax, evening reception, breakfast, and transfer to cruise with return to airport.
